Judge Mulroy was also the Supervising Judge of the Law Division's Mandatory Arbitration Program and was the author of the Program's rules.

Now he uses his depth of legal experience and broad perspective to mediate difficult disputes. He knows litigation can be very personal and stressful and therefore, is meticulous about learning the details of each case. Mulroy gives the participants confidence that he understands their positions.
